



Release of Liability and Assumption of Risk

In consideration of the services of Corsner Entertainment dba 3 Monkeys Inflatables, it's employees and agents collectively, Corsner Entertainment dba 3 Monkeys Inflatables. I agree to hold harmless and indemnify Corsner Entertainment, dba 3 Monkeys Inflatables on behalf of myself and my family members, partners, heirs and assigns as follows:

1. I acknowledge that using a Rock Wall, Euro Bungee, or any mechanical machine or equipment entails risks that could result in physical or emotional injury, paralysis, death, or injury or damage to me, to property, or to third parties. I understand that the risks cannot be eliminated without jeopardizing the essential qualities of activity. The risks could result in musculoskeletal injuries, including head, neck, and back injuries.
2. I accept and assume all the risks of participation in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I **release and agree to indemnify and hold harmless** Corsner Entertainment dba 3 Monkeys Inflatables from any claims that are in any way connected with my participation in this activity or my use of Corsner Entertainment dba 3 Monkeys Inflatables equipment or facilities, **including claims** that Corsner Entertainment dba 3 Monkeys Inflatables was negligent. However, I do not release any claims related to intentional or reckless acts by Corsner Entertainment dba 3 Monkeys Inflatables.
4. I have adequate insurance to cover any injury or damage I may cause or suffer while participating or I agree to bear the costs of any injury or damage.
5. I agree that, If I bring a lawsuit against Corsner Entertainment dba 3 Monkeys Inflatables, I will do so solely in Pennsylvania or Maryland (whichever the event holds place in) and the substantive law of Pennsylvania or Maryland will apply in that lawsuit without regard to the conflict of law rules. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Corsner Entertainment dba 3 Monkeys Inflatables on the basis of any claim from which I have released them.
