In consideration for myself, my child, or ward being permitted to play and/or participate in any party or activity at Dizzy Family Fun Center, the undersigned, on his or her behalf and on behalf of the participants identified below, appreciates, acknowledges and agrees to the following:

1. To follow the safety instructions stated or posted and acknowledge that failure to do so may result in expulsion from Dizzy Family Fun Center.
2. I am aware that inflatables can be hazardous, dangerous, and there are inherited risks associated with participation in activities at Dizzy Family Fun Center that can result in serious personal injury, including the potential for paralysis and death.
3. I, on behalf of myself and participants named below assume knowingly and freely all such risks, both known and unknown, to include those that may arise from negligence of others.
4. I hereby release, waive and forever discharge and consent not to sue Dizzy Family Fun Center, its owners, employees, contractors, equipment manufacturers, building owners and participants to be referred to as "Releases" from all liabilities, claims, demands, losses, actions, costs, injuries or damages arising out of participation or use of the facility or equipment, on or off premises.
5. If despite this release, I, my child or ward, or anyone on either's behalf make a claim against any releases mentioned above I agree to indemnify, defend, save and hold harmless the releases and each of them from any litigation expenses, attorney's fees, loss liability, damage, or cost they may incur due to the claim made against any of the "releases" named above whether the claim is based on negligence of the releases or otherwise.

I acknowledge I have read this consent, release and waiver of liability agreement and acknowledged that I and/or minor or ward below, participation at Dizzy Family Fun Center is strictly voluntary and am aware that by signing I will assume all risks and waive all substantial rights that I and/or minor or ward would otherwise have to recover damages for losses occasioned by the releases fault, and sign it voluntarily and without inducement.
