## PlayGround Games Release & Waiver

As a participant of a PlayGround Games, related events (the "Event") and/or activities, I the undersigned, acknowledge, appreciate, and agree that: 1. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES or others, and assume full responsibility for my participation as a spectator or volunteer. 3. If I observe any unusual and/or significant hazard during my presence, I will remove myself from the area that I perceive as a hazard and shall bring such hazard to the attention of the nearest official of PlayGround Games. 4. I, for myself and on behalf of my heirs, assigns, personal representatives and/or next of kin, forever WAIVE, RELEASE, DISCHARGE and COVENANT NOT TO SUE, R. C. Miller Events & Entertainment Inc.: PlayGround Games, and their officers, directors, representatives, officials, agents and/or employees, subsidiaries, volunteers, OFFICIALS and/or assigns, as well as their independent contractors, sponsoring agencies, sponsors, advertisers, volunteers, and if applicable, owners and lessors of the premises used to conduct the Event (collectively, the "Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, and/or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE Releases OR OTHERWISE.
